The Federal Government, through their corrupt Income Tax, Customs and Excise Tax, Goods and Services Tax, Succession Duty and Estate Tax, and many other forms of theft, have been stealing not only money from Canadians from coast to coast for over a century, but their livelihoods (businesses), their farms, their homes, and, worst of all, their self confidence. It is time again to **‘build the Spirit of Canada’**.

We Canadians have witnessed for two or more years the exposure by Judge Gomery of the scandalous \$250,000,000 diversion to Liberals and their friends at a further cost of \$70,000,000, and it is not over yet. The Minister of Revenue (Goodale) boasts about a Federal surplus of over **\$9 billion dollars** over the past year. How does that happen? Well, I, for one, have had enough. In 1990, I began a construction business in the Okanagan Valley of British Columbia to build luxury chalets on mountaintops. I invested over \$200,000 of my inheritance in the venture, and due to inexperience and misplaced trust in a business advisor, I lost almost my entire inheritance over two and one half years. The company into which I invested over \$200,000 was Okanagan Chalets Inc., which went out of business in 1993.

Since 1995 approximately, I have attempted to settle these deductible losses with Revenue Canada (now Canada Customs and Revenue Agency, and I will simply refer to this executioner as “The Taxman”), but there has been no real attempt by the taxman to resolve our differing opinion on my tax liability. In fact, other than the constant threatening letters in Her Majesty’s Canada Post for two years, the taxman ignores my pleas to meet and talk.

However, unknown to myself, my employer was served with a “Requirement to Pay” the sum of \$120,000, more or less, by the taxman two weeks ago. Two years ago, the taxman seized \$79 from VanCity Credit Union out of my personal bank account, and I laid a criminal charge of theft under the Criminal Code of Canada in the Provincial Court of British Columbia (Criminal Division), Burnaby Registry, which the Crown Prosecutors have refused to proceed with to date.

I will now go on record to state that if my employer turns over any of my income earned to the taxman as a result of their alleged tax liability, I will charge The Minister of Revenue **John McCallum** with theft and wrongful conversion of my money, as well as begin a nation wide organization of citizens, of professionals (Doctors, Lawyers, Architects, Engineers) of industrialists and manufacturers, of small businessmen and farmers, of trade unions and political groups and associations, and home owners and family men and women, who also see the theft of their monthly incomes by the Federal Government.
